
Advocacy spending hits new high

Federal lobbying spending topped \$4.5 billion in 2024, making gains that outpaced inflation – a noteworthy milestone given that Congress had other distractions in an election year. This report focuses on the performance of firms that disclosed \$1 million or more in lobbying revenue in filings with the Senate and House.

Washington influence spending hits record \$4.5 billion in 2024

Washington's influence industry grew to a new high in 2024, with clients turning to lobbying professionals as they sought to shape federal policies.

Disclosures required by law - which cover much but not all federal advocacy activity - showed \$4.53 billion in spending last year, up from \$4.35 billion in 2023, according to a Bloomberg Government analysis.

That revenue was driven by evergreen issues such as tax, health, and appropriations, as well as emerging ones including artificial intelligence and cryptocurrency.

That increase outpaced the 2.9% jump in the Consumer Price Index, reflecting a true expansion of overall lobbying income. Some of the largest firms, including Cornerstone and Holland & Knight, registered double-digit gains, while smaller players including CLS strategies more than tripled the amount of revenue disclosed in Lobbying Disclosure Act filings. Regulations drove some of the revenue, as clients hired representation to reflect their interests during an especially heavy rule-making year.

The George Washington University's nonpartisan Regulatory Studies Center examined economically significant federal rules promulgated in each presidential term and concluded that the 300 regulations completed by the Biden administration were the most ever. The first Trump administration was second, with just under 250 rules finalized.

Congressional work ahead of this year's expiration of the 2017 tax law, plus the routine spending-bill decisions, also drove lobbying revenue in 2024, said Hunter Bates, co-leader of lobbying and public policy practice at Akin Gump.

There was "a lot of appropriations activity, as everyone was looking to try to wrap up what people hoped would be a year-end package of appropriations bills, which unfortunately did not happen," said Bates, a former chief of staff and legal counsel to Sen. Mitch McConnell (R-Ky).

Drug prices and PBMs

Among last year's hot issues was a debate over undoing or changing the law that gave Medicare new authority to negotiate directly on the prices paid for some prescription drugs.

That topic's likely to continue to drive advocacy spending in 2025.

"President Trump suggests that he wants to do more in this space as well," said Sonja Nesbit, a senior policy advisor at Arnold & Porter.

It's an issue intertwined with debates about overall federal spending, because the Congressional Budget Office has estimated Medicare drug negotiations will have saved the government \$25 billion by 2031.

"If you try to jettison those provisions, writ large, it's going to cost the federal government money," said Nesbit, a former House Ways and Means Committee and Department of Health and Human Services staffer.

The unsuccessful post-election push to try to include in a December omnibus package language requiring middleman firms, known as pharmacy benefit managers, to disclose what they pay for prescription drugs was another driver of lobbying revenue. Lawmakers are already revisiting the issue.

Al, crypto

Technology issues keeping lobbyists busy in 2024 are on track to remain revenue drivers in 2025. Chief among those is artificial intelligence, which has been getting attention from both parties.

The Senate had a bipartisan working group in the last session, and Sen. John Thune (R-S.D.) helped move an Al bill in the Commerce Committee before he became majority leader.

"The fundamentals remain very strong for at least incremental initial actions from Congress," Reggie Babin of Akin Gump said.

In addition, President Donald Trump has called through executive orders for more work on both Al and cryptocurrency.

"Al is being crowded out in the headlines, but it's not being shoved aside when it comes to committee work," Bates said.

Lobbyists with tech expertise have especially been in demand since the 2022 collapse of FTX, one of the world's largest cryptocurrency exchanges. That sector-rattling event sparked increased interest on Capitol Hill, said Scott D. Mason, a senior policy advisor at Holland & Knight.

"The failure of FTX drove a certain level of curiosity as much as it drove concern," said Mason, who served as director of congressional relations for Trump's first presidential campaign and then worked on the 2016 transition team.

"It created an opportunity for members and staff to take a moment and actually sit down and learn a little bit about the industry, learn the benefits of blockchain technology," he said.

The House last year passed crypto regulatory legislation with significant Democratic support, including the votes of three House members who now are in the Senate - Adam Schiff (Calif.), Andy Kim (N.J.), and Ruben Gallego (Ariz.).

Though the bill died in the Senate, interested clients and their lobbyists now have a foundation they hope to build on.

"There's still a little bit of a learning curve among those members who may not be on the Financial Services or Banking committees, but it's a much, much smaller learning curve today than it was two, three, four, or five years ago," Mason said.



Capitol Hill veteran shows how lobby shops can build fast

A veteran Capitol Hill player with a new-on-thescene company scored a seven-figure debut season, according to lobbying data compiled by Bloomberg Government.

Former Akin partner Brendan Dunn launched Phronesis DC in 2024 and reported \$1.6 million in first-year lobbying revenue. One of Dunn's areas of expertise is the 2017 tax law, which he helped shape as a congressional staffer.

Many parts of the law are set to expire in 2025, and extending those is a priority for President Donald Trump and Republicans on Capitol Hill.

Dunn, who previously worked for the Senate Finance Committee and for Sen. Mitch McConnell (R-Ky.) said in an interview that the need for tax policy expertise will extend beyond whatever Congress does in 2025.

"Tax is always a front-of-mind concern for companies, regardless of industry," he said.

Dunn started Phronesis with Brett Quick, a former staffer with the House Financial Services and Senate Banking committees.

After leaving Capitol Hill, Quick served as head of government relations for the nonpartisan Financial Services Forum and the Crypto Council for Innovation.

Clients including Crypto Council followed Dunn and Quick to the new firm, creating a hectic startup period. Dunn said they needed "an extra 30 hours in the week" to get the fledgling business off the ground in those early stages.

"You're servicing those clients the same way that you were previously, while at the same time having a night job of trying to stand up a business and figure out everything that that entails," Dunn said.

"It's a good problem to have. I was fortunate to have a lot of long-term clients join us at Phronesis," he said. "That's better than starting out fresh on day one."


When Dunn left the Senate in 2018 to join Akin Gump, McConnell said in a Senate floor speech that he wasn't sure whether then Finance Chairman Orrin Hatch (R-Utah) "ever quite forgave me" for poaching Dunn from his committee a few years earlier.

"If you have ever had the pleasure of witnessing Brendan in action, you will understand why he is a sought-after commodity, whether you need deep expertise on tax policy or the perfect movie quote for any occasion," McConnell said.

Other first-time Lobbying Disclosure Act filers with noteworthy revenue totals included:

- \$1.2 million reported by Brian Glackin, a retired U.S. Navy captain and former Livingston Group partner who earlier served as deputy director of the Navy Appropriations office on Capitol Hill
- \$810,000 reported by Corbin Strategies, led by Kim Corbin, a Pioneer Public Affairs partner and minority staff director for the Senate Finance Health Care Subcommittee



Dramatic surges punctuate decade of lobbying firm analysis

The influence industry has seen a mixture of dramatic surges, incremental growth, and stagnation over the last decade, Bloomberg Government's 10th annual examination of lobbying data shows.

The largest revenue change was for a firm that began with a single lobbyist: Heather Podesta.

Podesta, a former staffer for Democratic Reps. Robert Matsui (Calif.) and Earl Pomeroy (N.D.), and for Sen. Bill Bradley (N.J.), founded her theneponymous firm in 2007. It was later rebranded as Invariant.

In its Lobbying Disclosure Act filings, Invariant reported \$42.3 million in revenue for congressional advocacy in 2024, up from \$7 million in 2014.

That gain in lobbying receipts was the largest of any firm over the decade.

Invariant's clients include Fortune 500 companies, trade associations, nonprofits, startups that have only gone as far as early Series A funding, "and everyone in between," said Lindley Kratovil Sherer, co-chair of Invariant's government relations practice.

"Over the last decade, Invariant evolved from a government affairs boutique into a full-service business advisory firm," she said.

Invariant's biggest clients last year included Apple Inc.; Palantir Technologies, a software firm focused on big data analytics and artificial intelligence; and the biofuel company Poet LLC.

Also experiencing a dramatic jump from 2014 to 2024 was Thorn Run Partners, with a 467% gain in revenue reported on legislative disclosure forms - to \$29.8 million, up from \$5.25 million.

The firm was started in 2010 by Andrew Rosenberg and Chris Lamond, who previously worked on the staffs of Sens. Edward M. Kennedy (D-Mass.) and Fred Thompson (R-Tenn.).

Thorn Run's major clients last year included eBay Inc.; the American Society of Composers, Authors and Publishers; and the Biosimilars Forum, which represents companies that make versions of biotechnology drugs after patent protection expires - akin to generic versions of regular pharmaceuticals.


They're among nine firms that more than doubled reported lobbying revenue since Bloomberg Government started analyzing the annual data.


The reported totals offer a partial look at firms' financial health because the law doesn't require filings to reveal every dollar brought in for every purpose.

Grassroots and messaging campaigns, for instance, are exempt, and individuals aren't required to register if they spend less than 20 percent of their time on lobbying activities and have made more than one direct contact with Capitol Hill or with executive branch officials.

Lobbying shops with the most reported revenue in 2024 with 2014 comparisons.





By percentage increase.



Standout firms of 2024

Bloomberg Government's analysis identified firms that also achieved high scores on other metrics, earning the "standout" designation. These firms retained 80% or more of their clients from the preceding year, and 60% or more of their clients over three years. They also posted revenue-per-lobbyist of \$600,000 or more.
